'Non-Inclusive' vs. 'All-Inclusive': What's The Difference?

Surrogate Angels of San Antonio™ utilizes two different types of Gestational Contracts to provide the best service to our Intended Parents and Gestational Surrogates alike. We offer an "All-Inclusive" and a "Non-Inclusive" contract setup. The outline below highlights the difference between the two:



The "All-Inclusive" Gestational Contract

Surrogate Compensation — \$20,000 - \$26,000+

- First-time Surrogates will receive \$20,000 (non-negotiable) for their Surrogate Compensation.
- Experienced Surrogates can expect to receive \$22,000 to \$26,000 (based upon medical and gestational history).
- Compensation begins the month following the RE's official confirmation of pregnancy (determined by fetal heartbeat via ultrasound).
- Compensation payments are distributed over ten months.

Additional Fees (if needed) —

Transfer Fee - \$500

Cancelled Cycle - \$300 *(If Surrogate is not at fault)*

Mock Cycle - \$500 *(If required)*

Surrogate & Spouse Psychological Screening - \$500 to \$800

Surrogate Attorney - \$350 *(for review of contract only)*

Travel & Medical Expenses - \$200 *(Monthly - Prior to confirmed pregnancy)*

Multiples - \$2,000 *(per additional child, paid after birth)*

Loss of Reproductive Organs - \$5,000

Lost Wages - TBD between Surrogate and Intended Parents

C-Section Fee - \$1,500

Invasive Procedure - \$500

Surrogate Counseling - \$600 *(If not covered by Surrogate's health insurance)*

Surrogate Term Life Insurance - \$200 *(paid for by IPs, required for duration of pregnancy)*

NOTE: Fees listed above are determined by Surrogate Angels of San Antonio™ and are non-negotiable except as listed.

Travel & Medical Expenses

For the All-Inclusive Contract setup, all travel and medical expenses incurred by the Surrogate prior to the confirmation of pregnancy (mileage, parking, food, prescriptions, etc) will be covered in the monthly Expense Allowance provided by the Intended Parents. After pregnancy is confirmed (via detection of fetal heartbeat through ultrasound), Surrogate will assume all travel related costs out of her monthly Surrogate Compensation.



The “Non-Inclusive” Gestational Contract

Surrogate Compensation — \$17,000 - \$24,000+

- First-time Surrogates will receive \$17,000 (non-negotiable) for their Surrogate Compensation.
- Experienced Surrogates can expect to receive \$20,000 to \$24,000 (based upon medical and gestational history).
- Compensation begins the month following the RE’s official confirmation of pregnancy (determined by fetal heartbeat via ultrasound).
- Compensation payments are distributed over ten months.

Additional Fees (if needed) (Fees unique to Non-Inclusive Contract shown in red) —

Transfer Fee - \$500

Cancelled Cycle - \$300 (If Surrogate is not at fault)

Mock Cycle - \$500 (If required)

Surrogate & Spouse Psychological Screening - \$500 to \$800

Surrogate Attorney - \$350 (for review of Gestational Contract only)

Travel & Medical Expenses - \$200 (Monthly - Prior to confirmed pregnancy)

Multiples - \$2,000 (per additional child, paid after birth)

Loss of Reproductive Organs - \$5,000

Maternity Clothing Allowance - \$500

Childcare - \$50 per day (if bedrest is prescribed by OB-GYN)

Housekeeping - \$80 per week (if bedrest is prescribed by OB-GYN)

Lost Wages - TBD between Surrogate and Intended Parents

Doctor’s Visit Co-pay (Based on Surrogate’s insurance co-pay)

C-Section Fee - \$1,500

Invasive Procedure - \$500

Surrogate Counseling - \$600 (If not covered by Surrogate’s health insurance)

Surrogate Term Life Insurance - \$200 (paid for by IPs, required for duration of pregnancy)

NOTE: Fees listed above are determined by Surrogate Angels of San Antonio™ and are non-negotiable except as listed.

Travel & Medical Expenses

For the Non-Inclusive Contract setup, all travel and medical expenses incurred by the Surrogate prior to the confirmation of pregnancy (mileage, parking, food, prescriptions, etc) will be covered in the monthly Expense Allowance provided by the Intended Parents. After pregnancy is confirmed (via detection of fetal heartbeat through ultrasound), Surrogate will only receive reimbursement of her office co-pays and travel mileage (at \$.55 per mile).
