Schedule of Fees

Surrogate Angels of San Antonio™ (SASA) Agency Fee** — 2 Payment Options:

• **Installment Option- \$10,000** - Payable in three installments, due as follows: the first installment at signing of the Agency Contract; the second due upon signing of Gestational Contract; and the third upon confirmation of the pregnancy by detection of fetal heartbeat via ultrasound.

• **Pre-payment option- \$8,000** - Payable in full at the time of signing the completed Agency Contract.

** SASA initially offers preliminary profiles of select Surrogates; however, to receive the full Surrogate profiles we require all Intended Parents to sign and submit the Agency Contract together with the Agency Fee. SASA's fee does not include legal fees, Surrogate compensation or additional expenses. We accept Visa®, MasterCard®, Discover® and American Express®, in addition to personal and certified checks.



SASA will facilitate the following services:

- Intended Parents' background check and psychological testing (paid for by Intended Parents).
- Recruitment and pre-selection of possible Gestational Surrogate Candidates.
- Scheduling and arranging the first meeting between Intended Parents and Surrogate Candidates.
- Screening of Surrogate Candidates, including psychological testing, home visits and reports.
- Counseling (as needed) for all parties.
- Coordinating with the fertility specialist from initial medical process to implantation.
- Negotiation of Gestational Agreement between Intended Parents and Surrogate.
- Overseeing disbursement of Surrogate Compensation, as disbursed by the firm of Allison-McCloskey.

Surrogate Compensation — \$23,000 - \$28,000+

- Compensation begins the month following the RE's official confirmation of pregnancy (fetal heartbeat via ultrasound).
- Compensation payments are distributed over ten months.

Surrogate Counseling	\$600	(If not covered by Surrogate's health insurance)

Escrow Fee	\$800	Disbursed by the firm of Allison-McCloskey (\$700 initial fee and \$10 per check disbursed)

NOTE: Fees listed above are determined by Surrogate Angels of San Antonio™ (with certain exceptions) and are non-negotiable except as listed.

TOTAL EXPENSE RANGE — \$30,500 - \$38,500

NOTE: This estimation does not include the cost of the IVF cycle and medications. The amount for the cycles is determined by the clinic and RE, the number of transfers required to achieve pregnancy and the needed medications. If you have insurance that covers infertility, your rates are likely to be much lower.

These fees are just an estimate of what the Intended Parents may expect. First-time Surrogates will receive \$23,000 (non-negotiable) for their Surrogate Compensation. Experienced Surrogates can expect to receive \$24,000 to \$28,000 (based upon her medical and gestational history).

***Agency Refund Policy: All agency fees are non-refundable for our considerable work, time, and experience.**

If, for any reason, a matched Surrogate chooses not to move forward before the transfer takes place, or if medical or psychological screenings determine she is inappropriate, Surrogate Angels of San Antonio™ will match you with another Surrogate at no additional charge.

Surrogate Reimbursable Expenses

At the time the Surrogate is selected by the Intended Parents, she will receive a \$200 monthly allowance from the Intended Parents to cover mileage, parking, food, prescriptions, etc. as she travels to doctor's appointments. This will be in effect from the first appointment until confirmation of pregnancy, at which time the monthly compensation takes effect.

Medical Expenses / Psychological Exam

It is the Intended Parents' responsibility to ensure that a credit card is on file with their Fertility clinic so the Surrogate's testing can be completed in a timely manner. Also, if the Surrogate requires a psychological evaluation the Intended Parents will be responsible for payment before the Surrogate undergoes the testing.

Surrogate Compensation Disbursement

We have retained the services of Allison-McCloskey, a well-established escrow company to disburse the monthly compensation of the Surrogates. We will work with each set of Intended Parents to ensure the monthly compensation money is deposited with Allison-McCloskey in a timely manner. Allison-McCloskey provides monthly statements to the Intended Parents, and SASA oversees them by authorizing the disbursements on the Intended Parents' behalf.

Legal Fees

SASA has enlisted the services of the Law Office of David Cole to prepare and file the following: the Gestational Contract; the Petition to Validate Gestational Contract and Adjudicate Parentage; the First Hearing for Pre-Birth Order; Interlocutory Order Validating Gestational Contract (Pre-birth Order); Final Hearing and Order; and any additional documents that may need to be filed with the Bureau of Vital Statistics. The fee for all legal services is \$3,400. This fee is paid directly to the Law Office of David Cole and is not included in the Agency Fee.
